# **Chairman's Report:**

- National recently sent notices that each LSC is required to submit its audit report within 90 days of the end of the fiscal year. Rather than hiring an outside audit firm to audit our accounts, she requested that we formally set up an Audit Committee as defined in the ByLaws and also requested approval to add Gerry Lindner to the committee because of his expertise in this area.

**Motion:** To set up an Audit Committee as defined in our ByLaws with the addition of At Large member Gerry Lindner. **(PASSED)** 

**Treasurer:** Monthly financial reports were distributed.

**Age Group Chair:** At John Burke's request the following motion was submitted as follow-up to December's discussions regarding funding coaches training:

<u>Motion:</u> To reimburse MSI clubs up to \$500 annually for reimbursements for registration fees for clinics attended by their coaches. Eligible clubs are those which are year round clubs with an age group program (12 and under swimmers). Seasonal clubs are not eligible. Eligible coaches must have passed the fundamentals of coaching or old ASCA Level 1 test. The annual period for reimbursement is from September 1 – August 31. A copy of the published registration fee and a listing of the coaches who attended must be submitted to the Treasurer. **(PASSED)**

<u>Motion:</u> To reimburse those clubs approved to host N2 meets (per MSI Meet Schedule) up to \$1,500/meet for travel and related expenses to bring in a qualified official to meet N2 certification meet requirements. **(PASSED)**
